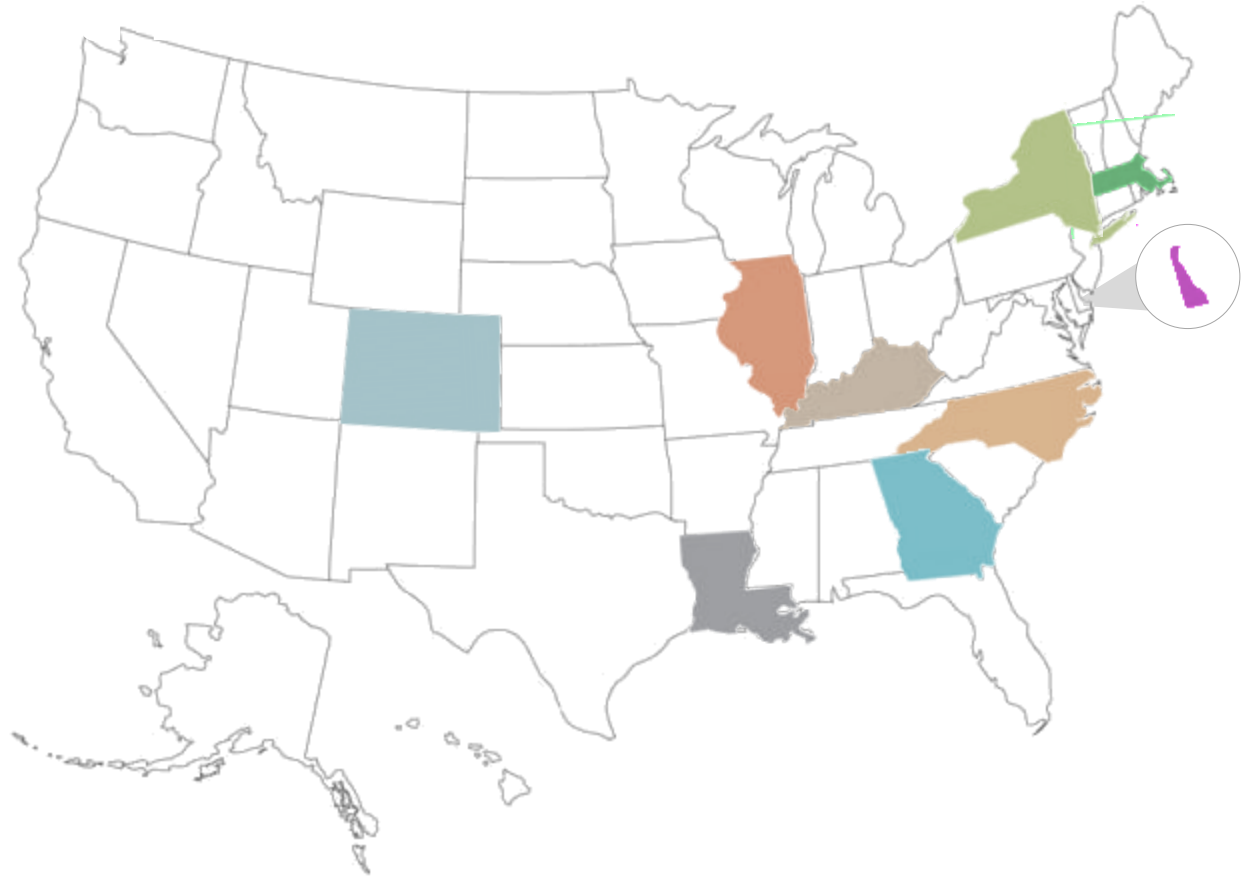

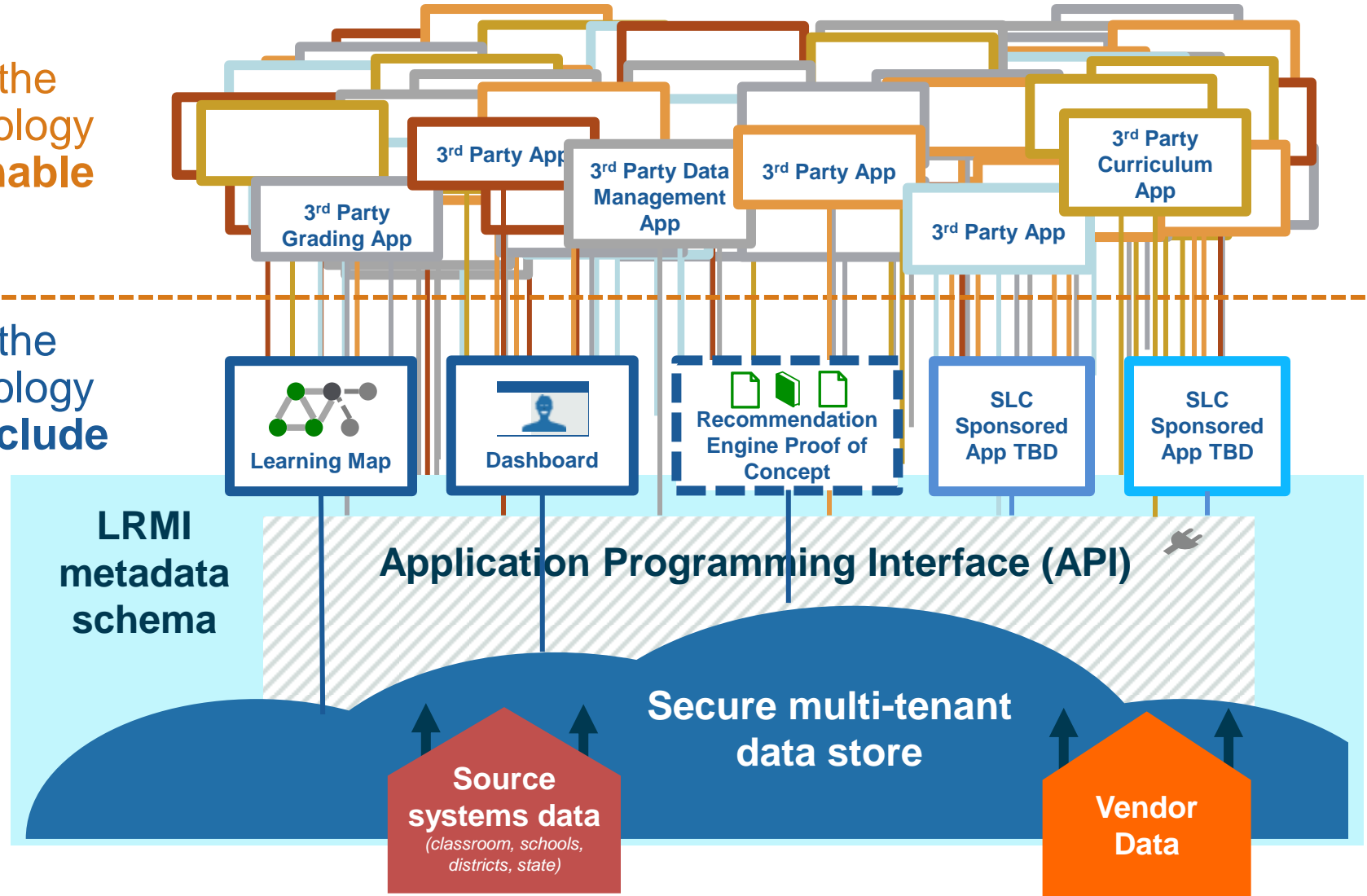

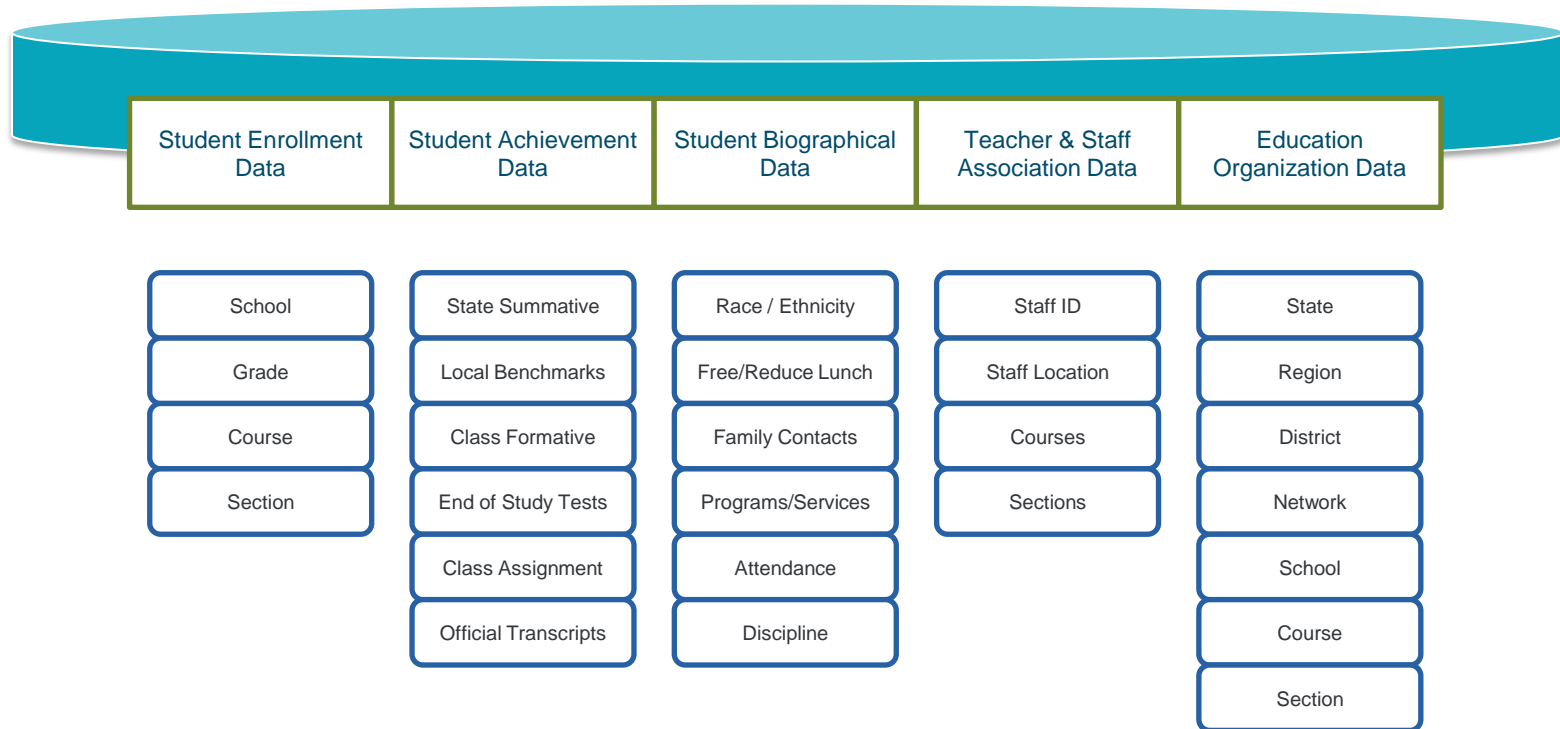

# The SLC Technology Data Store

SLC Technology offers a secure, multi-tenant data store. SLC Technology utilizes an open, XML-based data specification called **Ed-Fi** for its core entity model. The Ed-Fi Data specification adopts the naming of entities and attributes from the Common Education Data Standard (CEDS).

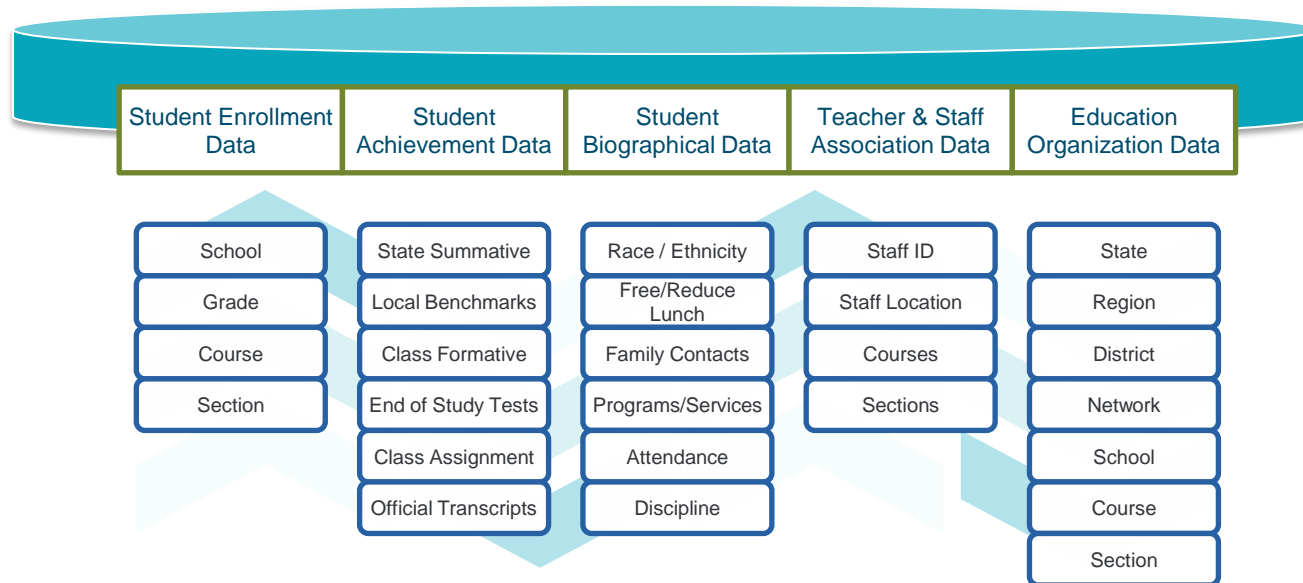
# Integration with Source Systems

The SLC Technology Data Store is being developed with the knowledge that source systems across states, local education agencies, and vendors are a highly diverse landscape.

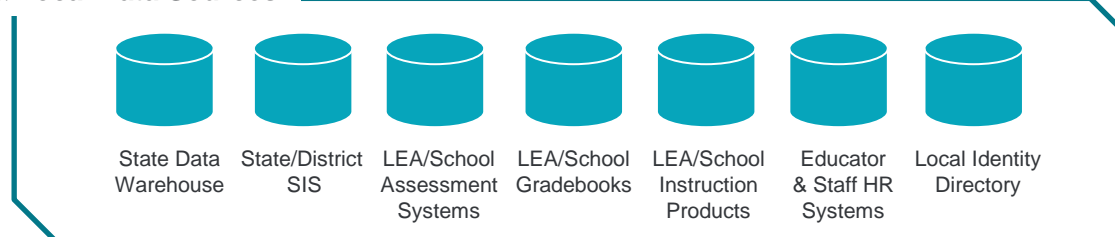
Data ingestion and extraction methods are being developed to address an assortment of needs.

Integration methods will include: XML, CSV, SIF ZIS Adapters, Event-driven API's

# Learning Resource Metadata Initiative



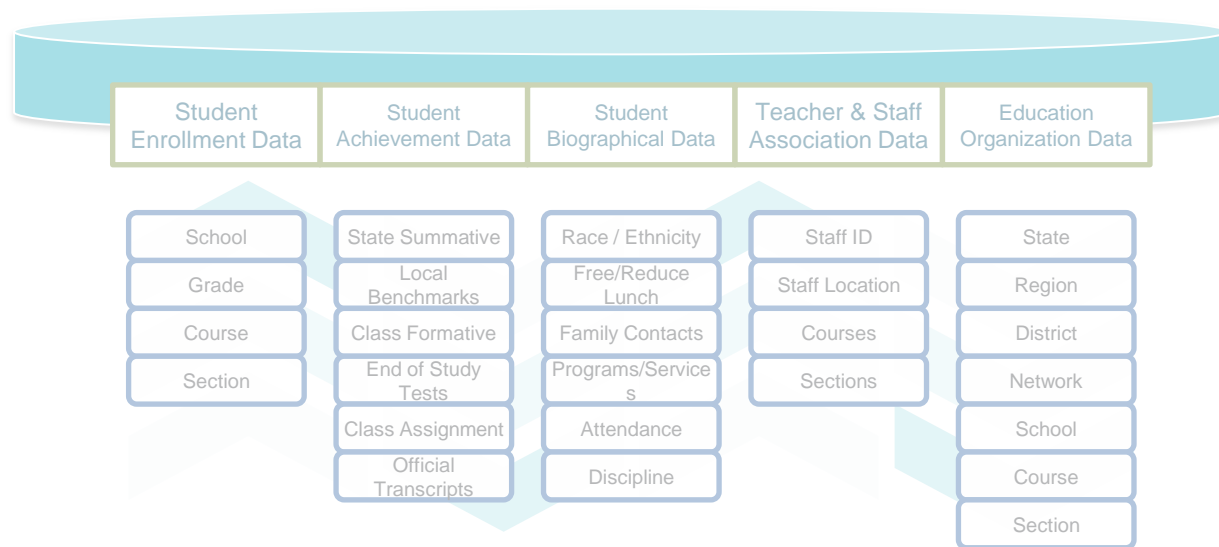
LRMI will create common metadata properties that distinguish content specifically used for learning.

Content in repositories will be tagged with LRMI-defined metatags and aligned to CCSS.

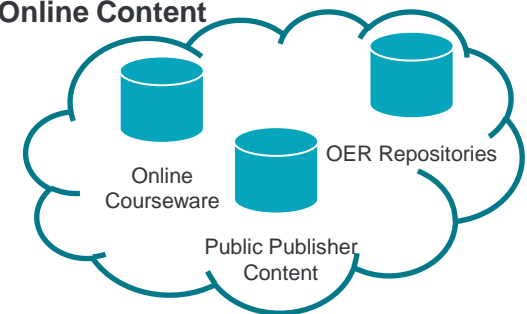
This content will announce and describes itself to the Learning Registry network.

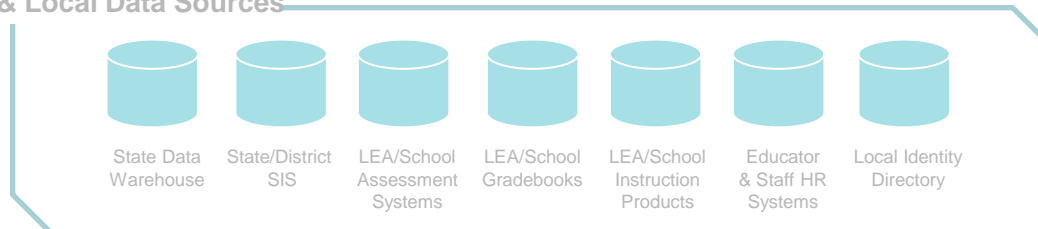

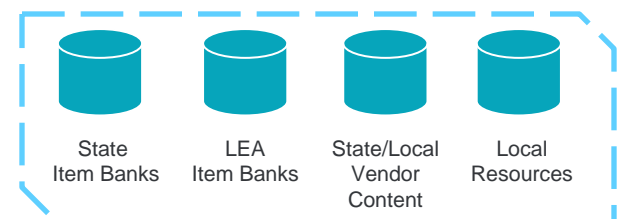

# The Learning Registry

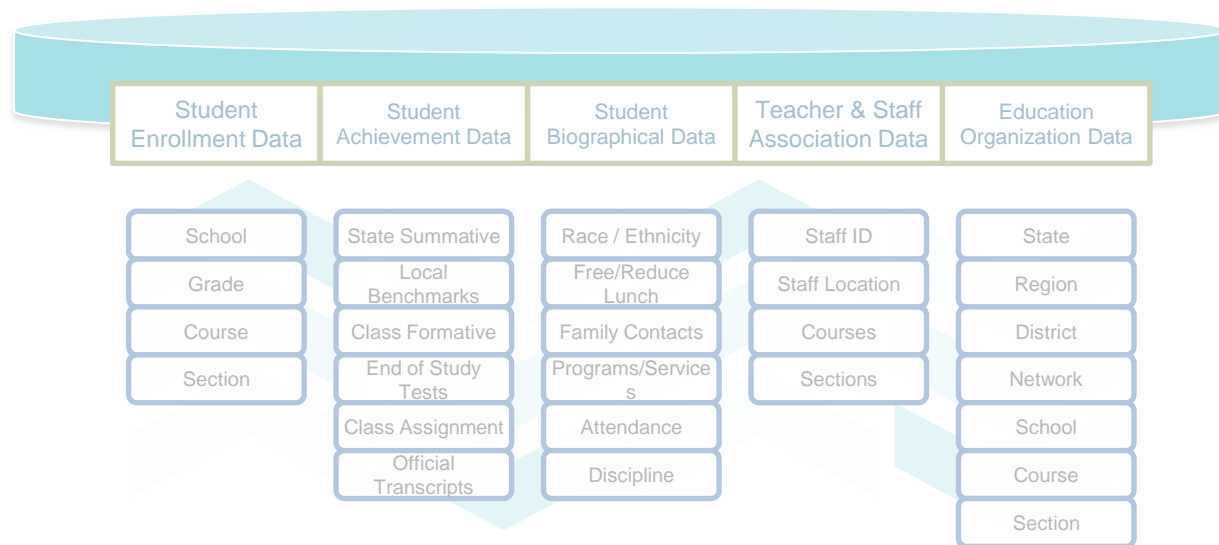
A network of learning registries will record messages about learning resources.

Information in the registry will include resource location, tags and activity.

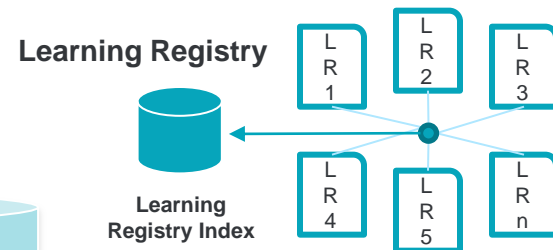
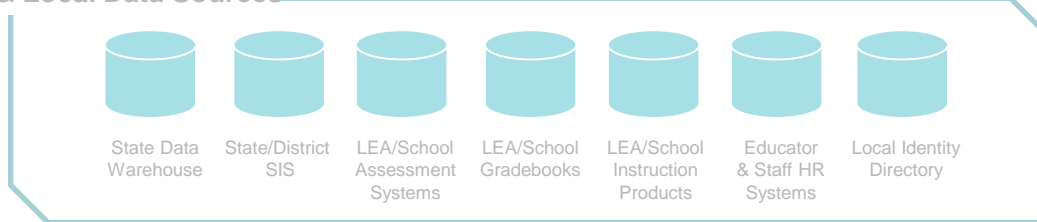
The SLC will build a Learning Registry Index aligned with the Common Core so applications and search engines can discover aligned content from across the internet.

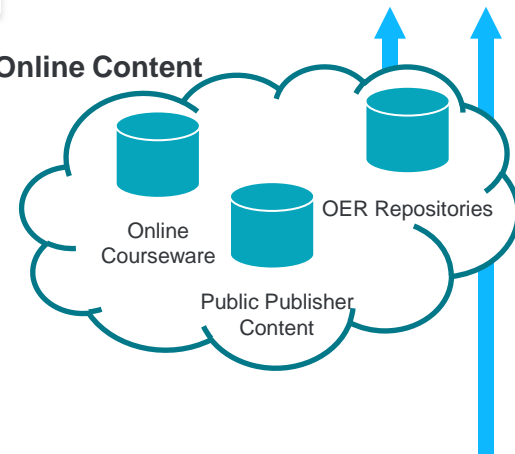

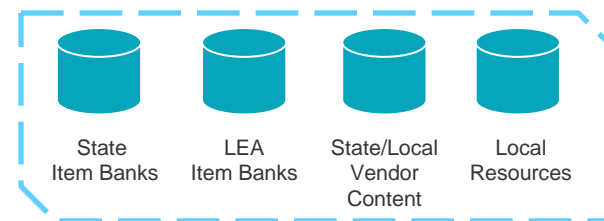

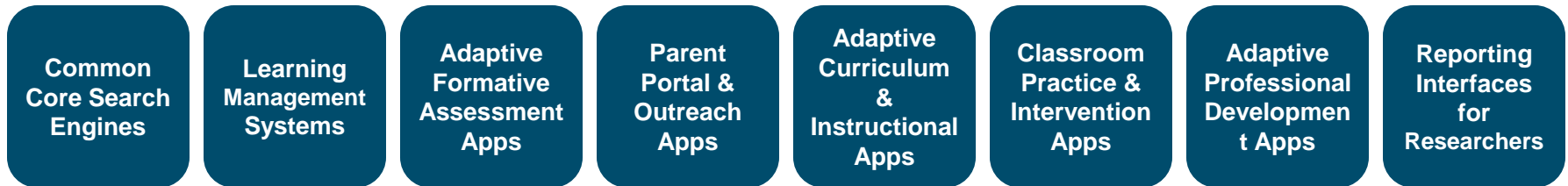

# SLC Technology Enables Applications

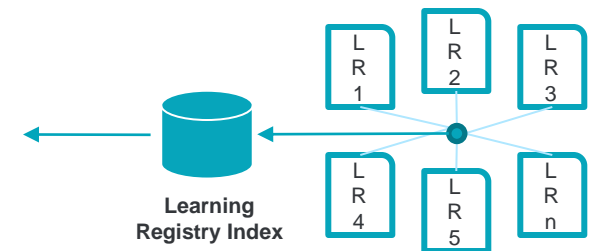

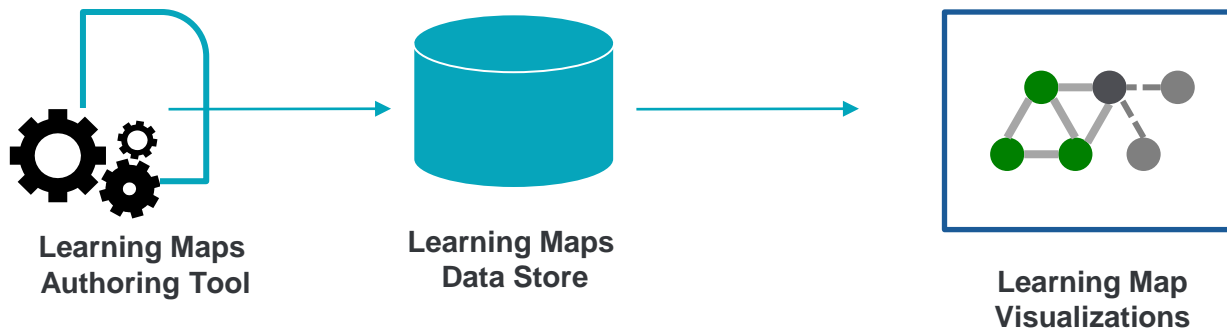


# Learning Maps

Learning Maps offer easy to use content standards browsing and provide baseline functionality to kickstart innovation in data reporting interfaces and recommendation engines.

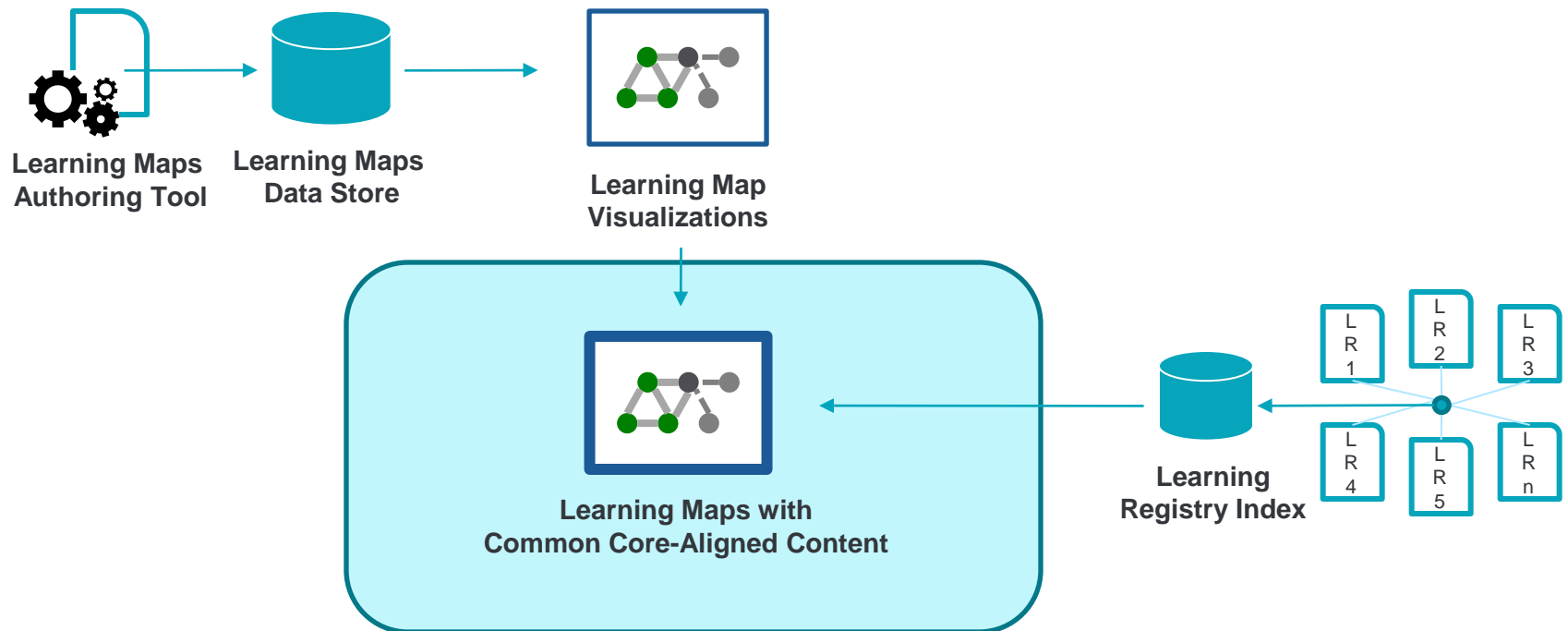
SLC will provide a Learning Map authoring tool for users to customize and publish their own path through the Common Core or to build new taxonomies for additional subjects.

The authoring tool will allow users to store paths and generate new visualizations.



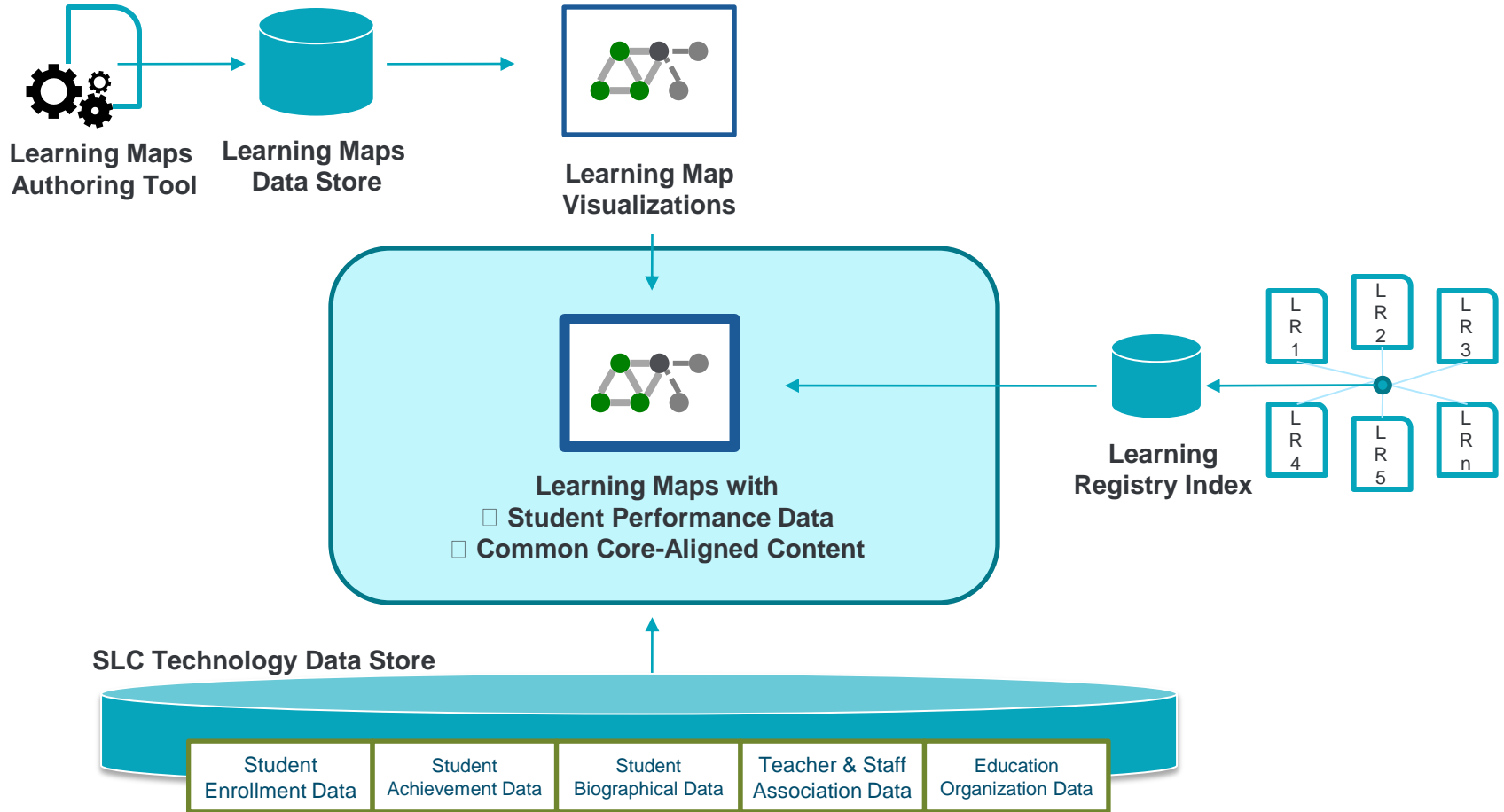

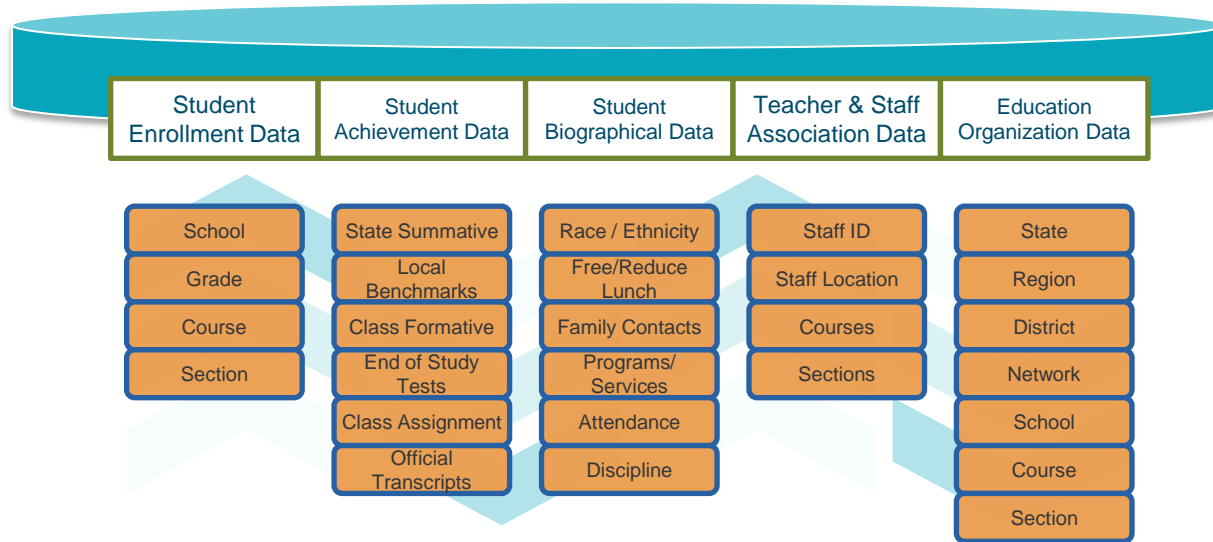
# App Example: Teaching & Learning Portal

A custom portal for educators could support a wide array of needs including: lesson planning, best practice collaboration, generating reports, and providing recommendations for educational content

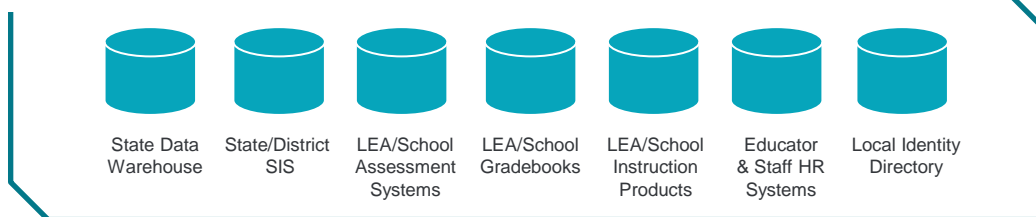

# Adaptive Assessment

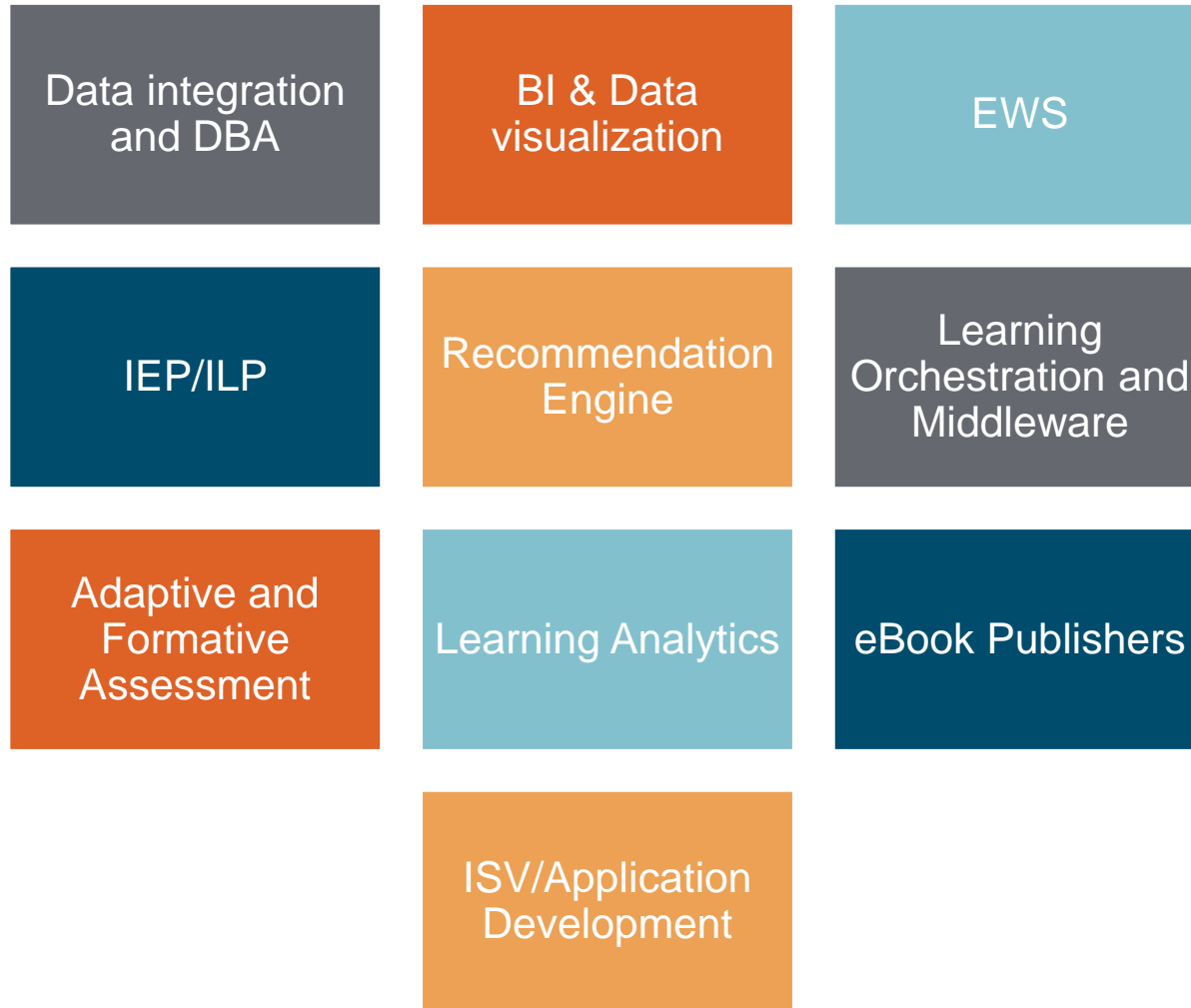
## Current pain points

- Time-consuming and costly data & system integration
- Limited available data
- Inconsistent identity management
- Expensive range of semantics and associated schemas
- Opaque resources
- Limited discoverability

## Services from the SLC

- Richest possible instructional data with built in extensibility
- RESTful Data API to minimize systems integration cost
- Federated authentication and identity service
- CCSS Learning Map as canonical reference for Standards and Microstandards
- LRMI to improve indexing & search
- Learning Registry discoverability and tracking

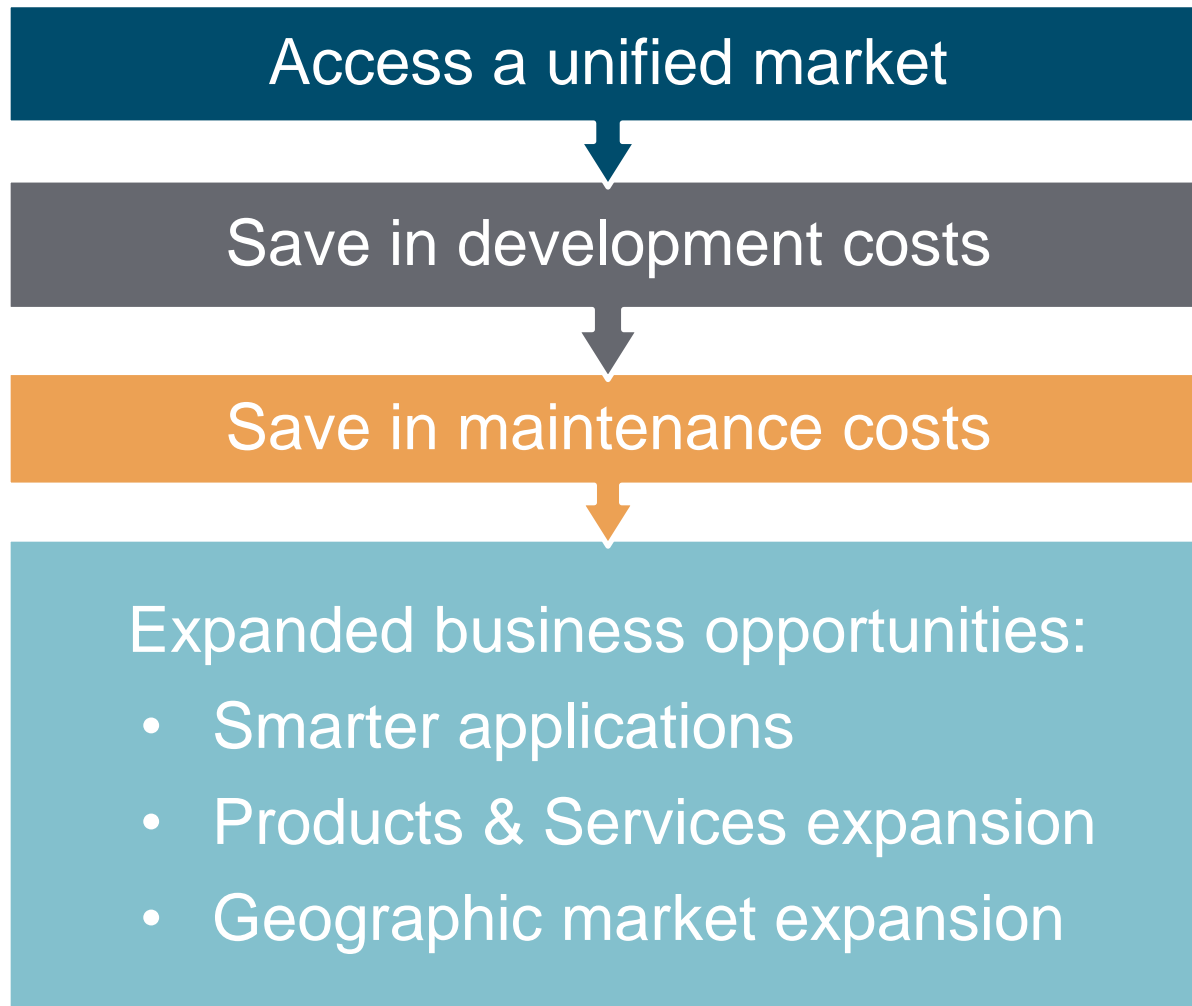
