Technical Aspects of Mandatory Deposit of Published Electronic Works Available Only Online

APRIL 12, 2011

After much anticipation, Sens. John Kerry (D-MA) and Joe Biden (D-DE) introduced the Commercial Privacy Bill of Rights Act of 2011. This legislation has gone a long way to address many key issues. That said, the bill is still a work in progress and sure to continue during consideration by the Committee and full Senate in the House, Commerce, Manufacturing and Trade Subcommittee. Chafee said Monday that she will continue to lead the charge on this legislation.

Bono Mack also said that legislation in this area will only move forward if it takes an up-to-date regulatory approach. She expects action must not hold back U.S. economic growth or compromise regulatory certainty as the key variable. She did, however, say more in the way of communicating with Internet users and businesses.

Also this week, the train continues to move forward on patent reform. Judiciary Committee scheduling a Markup for the America Invents Act. SIIA strongly supports patent reform and will continue working with the House and Senate towards the goal of enacting legislation soon.
