The U.S. Congress is on recess this week, following a budget vote that featured a shutdown-avoiding final FY2011 appropriations bill. The FY2012 budget proposal that cut trillions of entitlement spending, however, the budget is likely to dominate the federal legislative calendar.

Ed-Tech Government Forum held in Washington, DC

The averted government shutdown ensured that SIIA's annual [Ed-Tech Government Forum](#) took place as planned. SIIA brought more than 100 education leaders to Washington, DC for discussions with key education leaders and policymakers on the school software market. Attendees networked, discussed national education leaders, and took advocacy visits to do so.

Among the highlights were remarks by Senator Patty Murray and U.S. Education Secretary Duncan's Chief of Staff Joaquin Arreola. Presentations and session summaries will be [archived](#). ICANN releases new Guidebook

In other news, ICANN released a new version of the Draft Guidebook, continuing the debate over the rollout of new generic top-level domains. The Guidebook can be found [here](#). The public comment period is open, and SIIA is working on comments through its constituency process for Accountability.

Administration releases NSTIC

On Friday, April 15, the Administration released its [National Infrastructure and Cybersecurity Strategy](#) (NSTIC). This "private sector-led infrastructure for the Internet, built on interoperable, private-sector standards and credentials," was released in conjunction with an event at the White House. The lead Administration agency is the National Institute of Standards and Technology, which announced at the same time that it will be moving forward with Trusted ID in the coming months.

Web Tracking and User Privacy Workshop to be held
